Entry Restrictions	Entry is open to residents of Australia aged 13 years or older at the commencement of the Promotion (Eligible Entrants). Eligible Entrants under 18 years of age must have the consent of their parent or guardian in order to enter. By entering this Promotion, Eligible Entrants confirm that they have consent, and the Promoter reserves the right to verify this.
Verification Requirements	Eligible Entrants must have completed the Entry Procedure in full.

First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion, and set out all of the information you need to know regarding this Promotion. Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is Netball Australia (ABN 66 003 142 818) of 191 Johnston Street, Fitzroy, VIC 3065 (**'Promoter', 'we', 'us'**).
3. Any updates to these Conditions of Entry will be subject to regulatory approval, and will be published on our website <https://www.supernetball.com.au/promotions>, so it's important to check these Conditions of Entry regularly.

Who can enter ... and who can't

4. The eligibility requirements for this Promotion are set out in the Entry Restrictions. Directors, managers, employees, officers, agents and contractors of the Promoter, and their immediate families (ie spouse, partner, parent, grandparent, natural or adopted child, and sibling (whether natural or adopted by a parent)) are ineligible to enter.

9. If that happens, we'll select a winner from eligible entries received at the time.

Prizes

Judging and Judging Criteria

14. Judging Details are set out in the Schedule. We will notify winners, and publish their names, in accordance with the Notification and Publication of Winners information set out in the Schedule.
15. Chance plays no part in determining any winners of this Promotion. Each valid entry will be individually judged (by representatives of the Promoter) based on the Judging Criteria. The prize/s

will be awarded to the valid entrant/s (as applicable) which best meet the Judging Criteria, as determined by the judges in their sole discretion. Judges' decisions are final and no correspondence will be entered into.

16. We accept no responsibility for any lost or misdirected mail, or any damage to prizes caused in transit.
19. If (having made reasonable efforts) we cannot contact a prize winner, or if any prize is not accepted or claimed by the Prize Claim Date, we will conduct an Unclaimed Prize Draw (subject to any directions given by relevant gaming authorities).
